TURF PARADISE RULING #18-19TP119

Having been properly noticed for a formal hearing and having failed to appear on March 19, 2019, Jockey Jose Francisco Arriola Serrano (ADG #21841) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failure to fulfill his riding engagement on March 4, 2019 at Turf Paradise Race Course.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by March 29, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning March 30, 2019 through and inclusive of September 26, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Owner/Trainer Kerri Lynn Raven (ADG #12228), is hereby given an official warning following receipt of a report from Industrial Laboratories indicating blood sample #E306287 taken from the horse "LEAGUE OF SHADOWS" winner of the fifth race on March 3, 2019, was confirmed positive for the presence of the Class V foreign substance OMEPRAZOLE SULFIDE (32.4 +/- 1.7 pg/mL).

Having been properly noticed for a formal hearing and having appeared, Trainer William David Tollett (ADG #15229) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failure to conduct business in a proper manner (honoring riding engagements) on March 25, 2019 at Turf Paradise Race Course.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 5, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 6, 2019, through and inclusive of October 3, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

TURF PARADISE RULING #18-19TP123

Having been properly notified of a hearing and having failed to appear, Apprentice Jockey Jose Arriola-Serrano (ADG #21841) is hereby suspended for ONE HUNDRED AND TWENTY days, from March 25, 2019, through July 23, 2019 (Credited with two days served after being summarily suspended on March 25, 2019) for refusing a field drug test as ordered by the Board of Stewards on March 25, 2019. In addition, the respondent must provide a negative urine sample and sign a drug testing agreement form prior to reinstatement.

During the term of his suspension, Apprentice Jockey Jose Arriola-Serrano is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division.

After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#1 Stratton**, who was on the outside did drift in slightly in late stretch causing the jockey of **#10 Yo Y Me** to check briefly, however **#10 Yo Y Me** also stepped out slightly at the same time when he switched his leads back to the left lead, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 4-1-10-2-9-6-8-7.

Race 4: STEWARDS INQUIRY/POOR START/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which seventh place finisher **#8 Smokin Wild**, ridden by Jose Leon, broke slowly and trailed the field. After reviewing the videos and taking testimony from the rider, the stewards determined that **#8 Smokin Wild** threw his head shortly after the start and ducked to the outside sharply,



however, the starting gate of **#8 Smokin Wild** opened in unison with the rest of the field and the assistant starter released the horse properly. The horse was given the opportunity of a fair start and therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 6-5-2-1-3-7-8. **#8 SMOKIN WILD** was put on the stewards list for running greenly and being distanced.

Public Announcement: **#8 SMOKIN WILD** worked out of the gate at Turf Paradise on 3/30/2019 3/8^{ths} in 37.80 handily.

Race 1: The rider of **#4 TENGAS PRAYER** lost his riding crop near the wire. The winner **#3 RESPECT THE BOSS** was pulled up near the six furlong pole but walked off under his own power.

Race 3: STEWARDS INQUIRY/START/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident shortly after the start involving second place finisher **#7 Something About Me**, ridden by Chad Lindsay, third place finisher **#6 Beauty Black**, ridden by Andrew Ramgeet, fourth place finisher **#3 Perfectly Seasoned**, ridden by Scott Stevens, and fifth place finisher **#5 College Queen**, ridden by David Lopez. After reviewing the videos and taking testimony from the riders involved, the stewards determined that shortly after the start **#7 Something About Me** veered inwards sharply causing severe bumping with **#6 Beauty Black**, **#5 College Queen**, and **#3 Perfectly Seasoned** and that this extreme interference cost all three (3) horses (**#6 Beauty Black**, **#3 Perfectly Seasoned** and **#5 College Queen**) the opportunity of a better placing, therefore, the stewards disqualified **#7 Something About Me** from second place and placed her fifth. The original order of finish of 1-7-6-3-5-2 was changed to 1-6-3-5-7-2.

Race 4: An owner change was announced to the public for **#1 WRIGHT WINGED**. The new owner is Nova Morales or Juan Quintana Gutierrez. There was a two way (2) shake for **#5 ROYAL FASHION** however the claim was voided.
