Significant Incidents /Matters:

Race 1: STEWARDS INQUIRY/START/DQ

Following the running of the race the stewards posted the inquiry sign due to an incident shortly after the start involving third place finisher **#10 Looken Good**, ridden by McKenzie King, eighth place finisher **#9 Ms Fast Dynasty**, ridden by Joseph Belloc, Jr., ninth place finisher **#8 Y Paint Linda**, ridden by Jake Samuels, and tenth place finisher **#7 Cockahoop**, ridden by Rudy Arvizu. After reviewing the videos and taking testimony from the riders involved, the stewards determined that shortly after the start **#10 Looken Good** veered in sharply causing severe bumping with **#9 Ms Fast Dynasty**, **#8 Y Paint Linda**, and **#7 Cockahoop** and that this extreme interference cost all three horses **#9 Ms Fast Dynasty**, **#8 Y Paint Linda**, and **#7 Cockahoop** the opportunity of a better placing, therefore, the stewards disqualified **#10 Looken Good** from third place and placed her tenth. The original order of finish of 1-4-~~10~~-6-2-3-5-9-8-7 was changed to 1-4-6-2-3-5-9-8-7-~~10~~.

Race 3: **#4 WOODBRIDGE MISS** was put on the stewards list for poor performance (beaten 35+ lengths).

Race 4: STEWARDS INQUIRY/POOR START/NO CHANGE

Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which eighth place finisher **#6 Sisu**, ridden by Patrick Canchari, broke slowly and trailed the field. After reviewing the videos and taking testimony from starter Denny Hall and the rider, the stewards determined the starting gate of **#6 Sisu** opened in unison with the rest of the field and the assistant starter released the horse properly. The

horse was given the opportunity of a fair start and therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 4-8-1-5-2-7-3-6.

An owner change was announced to the public for **#6 SISU** from Terra Firma Farm to Terra Firma Farm or Ed Zenker.

Race 5: A additional workout was announced to the public for **#10 DR. WATSON** which took place on April 13, 2019, at Turf Paradise. He worked 3/8^{ths} in :36.20 handily on a fast track.

Having been properly noticed for a formal hearing and having waived that right on April 13, 2019, Apprentice Jockey Jose A. Leon (ADG #23902) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED FIVE DOLLARS (\$105.00) for being late to the paddock for the first (1st) race on April 9, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 23, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 24, 2019 through and inclusive of October 21, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
A.A.C. R19-2-106(C); A.A.C. R19-2-121(E)

TURF PARADISE RULING #18-19TP132

Having been properly notified for a hearing, and having appeared, Trainer Fernando Gamez (ADG #11001) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for failing to properly identify the horse "PCR AMERICANFIGHTER" as a gelding at the time of entry in the 1st race at Turf Paradise Race Course on April 8, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 23, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 24, 2019, through and inclusive of October 21, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Having been properly notified for a hearing, and having appeared, Trainer Rigoberto Guillen (ADG #10890) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for failing to properly identify the horse "DYNASTY DINAMO" as a gelding at the time of entry in the 1st race at Turf Paradise Race Course on April 7, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 23, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 24, 2019, through and inclusive of October 21, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which **#6 Lion Command**, ridden by Jake Samuels, did not break from the gate. After reviewing the videos and taking testimony from starter Denny Hall and the rider, the stewards determined that the starting gate of **#6 Lion Command** opened in unison with the rest of the field and the assistant starter released the horse properly. The horse was given the opportunity of a fair start and refused to break of his own accord, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 9-5-3-2-4-8-7-1-(6-DNF). There was a five (5) way shake for **#2 PASCO**.

Race 8: A work was announced to the public for **#8 CHAPIS**. She worked 3/8^{ths} on April 12, 2019, at Turf Paradise in :38.0 handily on a fast track. It was also announced to the public **#8 CHAPIS** is first time Lasix. **#5 SUPAH SISTA** was put on the stewards list for poor performance (beaten 35+ lengths).

Race 5: **STEWARDS INQUIRY/STRETCH/NO CHANGE:** Following the running of the race the stewards posted the inquiry sign to review the stretch run of third place finisher **#4 Golden Chariot**, ridden by Francisco Arrieta, first place finisher **#7 Grace Hopper**, ridden by Glenn Corbett, and second place finisher **#1 Panochio**, ridden by Daniel Vergara. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#7 Grace Hopper**, who was on the outside, did drift in slightly near the 3/16th pole causing the jockey of **#4 Golden Chariot**, who was between horses, to check briefly, however **#4 Golden Chariot** always had running room and was not cost the opportunity of a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 7-1-4-8-5-3-6.

Race 6: **#10 STORM HOLLOW** was announced to the public as carrying a corrected weight of 124 pounds with the change of jockeys.

Race 7: The jockey aboard **#10 KANSASCITY SHUFFLE** dropped his riding crop near the 1/16th pole.
