Race 1: None

Race 2: STEWARDS INQUIRY/POOR START/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which eighth place finisher **#4 Migiwewin**, ridden by Francisco Arrieta, broke slowly behind the field. After reviewing the videos and taking testimony from starter Denny Hall and the rider, the stewards determined that **#4 Migiwewin** began to rear as the front doors were opening, however, the starting gate of **#4 Migiwewin** opened in unison with the rest of the field and the assistant starter released the horse properly. The horse was given the opportunity of a fair start and therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 8-1-7-2-5-3-6-4.

Race 4: STEWARDS INQUIRY/POOR START/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which **#7 House of Charm**, ridden by Patrick Canchari, did not break with the field and pulled up. After reviewing the videos and taking testimony from starter Denny Hall and the rider, the stewards determined that the starting gate of **#7 House of Charm** opened in unison with the rest of the field and the assistant starter released the horse properly, however **#7 House of Charm** refused to break. The horse was given the opportunity of a fair start and therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 3-4-1-5-8-2-6-(7-DNF).

Race 5: #3 DEL MAR DIVA was pulled up after the race and vanned off. The rider of **#1 NAUGHTY SWAGGER** lost his riding crop near the ¼ pole.

Race 6: There was a three (3) way shake for **#9 TIZJOHNDEERSWAY**.

Race 1: None

Race 2: It was announced to the public of an additional work for **#5 FOXY BY PROXY**. She worked on April 20, 2019, at Turf Paradise 3/8ths of a mile in 40 1/5 breezing from the gate on a fast track. It was announced to the public of an additional work for **#6 LADY BURNELLE**. She worked on April 20, 2019, at Turf Paradise 3/8ths of a mile in 39 4/5 breezing from the gate on a fast track. It was announced to the public that blinkers would be added to **#4 ONE PERKY MARGE** at the starting gate.

Race 6: STEWARDS INQUIRY/JOCKEY OBJECTION/STRETCH/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident near the 1/16th pole involving first place finisher **#5 Ladies Man**, ridden by Jose Leon, **#3 Cozy Bar**, ridden by Denny Velasquez, and third place finisher **#7 Prayinthepairie**, ridden by Daniel Vergara. There was also a jockey objection received from Daniel Vergara, the rider of **#7 Prayinthepairie**, against both **#5 Ladies Man** and **#3 Cozy Bar**, alleging interference in the stretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that near the 1/16th pole **#5 Ladies Man**, who was on the outside, veered inwards making contact with **#7 Prayinthepairie**, who was between horses, and putting that one in tight quarters, and **#5 Ladies Man** continued inwards causing the jockey of **#7 Prayinthepairie** to check. The stewards decision was that the interference caused by **#5 Ladies Man** cost **#7 Prayinthepairie** the opportunity of a better placing, thus **#5 Ladies Man** was disqualified from first place to third place. The original order of finish of **5-3-7-1-2-8-6** was changed to **3-7-5-1-2-8-6**. The claim for **#1 JOHN ARNOLD** was voided.
