TURF PARADISE RULING #18-19TP135

Having been properly noticed for a formal hearing and having waived that right on April 22, 2019, Owner/Trainer Mike Chambers (ADG #10967) is hereby fined TWO HUNDRED (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND FIVE (\$210.00) for failing to show up to the paddock with the horse "SHE'S OUR TIZBUD", resulting in a late scratch in the 4th race on April 16, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 2, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 3, 2019 through and inclusive of October 30, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

TURF PARADISE RULING #18-19TP136

Having been properly notified of a formal hearing, and having appeared on April 22, 2019, Trainer Curt Ferguson (ADG #10239), is hereby fined ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE THOUSAND FIVE HUNDRED AND SEVENTY FIVE DOLLARS (\$1,575.00) following receipt of a report from Industrial Laboratories indicating blood sample #E306514 taken from the horse "CIRCUS RIDE" winner of the second race on March 25, 2019, was confirmed positive for the presence of the Class IV foreign substance TRIAMCINOLONE ACETONIDE (149 +/- 15 pg/mL).

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 3, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 4, 2019, through and inclusive of October 31, 2019, and this matter is referred to the Director of the Arizona Department of

Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

TURF PARADISE RULING #18-19TP137

Having been properly noticed for a formal hearing and having appeared, Owner/Trainer Dickie Martinez (ADG #11340) is hereby fined TWO HUNDRED DOLLARS (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND TEN DOLLARS (\$210.00) for failing to honor the entry of the horse "GOTTA BE DIET C" for the third race on April 16, 2019, resulting in a late scratch.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 3, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 4, 2019, through and inclusive of October 31, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Significant Incidents /Matters:

Race 1: None

Race 2: # 7 CARMELO P was pulled up after the race and vanned off.

Race 3: STEWARDS INQUIRY/SPILL/START/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race involving #9 Coronados Choice, whose rider David Reyes-Frisby, was unseated at the start. After reviewing the videos the stewards determined that #9 Coronados Choice stumbled of her own accord unseating her rider. This action was not caused by any other horse; therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 6-1-10-5-3-2-8-7-4-(9-DNF).

Race 4: STEWARDS INQUIRY/JOCKEY OBJECTION/START/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident at the start involving the sixth place finisher #4 Bay Max, ridden by Jesus Virgen and the ninth place finisher #3 Texas Tornadoe, ridden by Luis Valenzuela. Jockey Luis Valenzuela aboard #3 Texas Tornadoe also lodged an objection against #4 Bay Max alleging interference leaving the starting gate. After reviewing the videos and taking testimony from the riders involved the stewards determined that #4 Bay Max broke inwards sharply making contact with #3 Texas Tornadoe and putting her in very tight quarters causing her to stumble and lose all chance of obtaining a better finish position. The stewards decision was that for interference leaving the starting gate #4 Bay Max was disqualified from sixth place and placed ninth. The original order of finish of 11-9-6-8-5-~~4~~-2-10-3-1 was changed to 11-9-6-8-5-2-10-3-~~4~~-1.

Race 5: It was announced to the public of a weight change for #6 SEVENTY SEVEN FLAT. Corrected weight was 124 pounds.

Race 6: None

Race 7: JOCKEY OBJECTION/STRETCH/NO CHANGE: Following the running of the race, Jose Leon, the rider of sixth place finisher **#2 Cheddar Jill**, lodged an objection against first place finisher **#9 Dislitleaglecanfly**, ridden by Luis Valenzuela, alleging interference in the stretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#9 Dislitleaglecanfly** did drift inwards mid-stretch under right hand use of the riding crop but there was always running room for **#2 Cheddar Jill** and it did not cost **#2 Cheddar Jill** a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 9-7-10-6-8-2-5-3.

Race 8: It was announced to the public of a weight change for **#7 DANNY'S PONTI**. Corrected weight was 124 pounds. **#8 POINT TO POINT** started pulling up going into the first turn, was eased on the backside and vanned off.

Race 5: #5 PUBLIC ENEMY was put on the stewards list for poor performance (beaten 35+ lengths).

Race 6: None

Race 7: STEWARDS INQUIRY/JOCKEY OBJECTION/STRETCH/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident in late stretch involving first place finisher #1 Westley, ridden by Jose Leon, second place finisher #7 Awesome E K, ridden by Luis Valenzuela, and third place finisher #4 Son of Eleanor, ridden by Scott Stevens. There was also a jockey objection received from Scott Stevens, the rider of #4 Son of Eleanor, against #1 Westley and #7 Awesome E K alleging interference near the wire. After reviewing the videos and taking testimony from the riders involved, the stewards determined that in late stretch #7 Awesome E K, who was on the outside, drifted in under right hand use of the riding crop making contact with #4 Son of Eleanor, who was between horses, putting that one in tight quarters and causing that one to make contact with #1 Westley, who was on the inside. The contact with #1 Westley turned that horse outwards, further putting the horse in the middle, #4 Son of Eleanor, in extremely tight quarters causing the rider of #4 Son of Eleanor to have to check sharply to avoid clipping heels. #7 Awesome E K was disqualified from second place to third place for costing #4 Son of Eleanor the opportunity of a better placing. The original order of finish of 1-7-4-6-3-2-8 was changed to 1-4-7-6-3-2-8.

Race 8: STEWARDS INQUIRY/SPILL/START/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race involving #10 Our Dandy's Boy, whose rider, Danny

Vergara, was unseated. After reviewing the videos the stewards determined that #**10 Our Dandy's Boy** threw his head down as his starting gate was opening causing him to break awkwardly unseating his rider. The starting gate of #**10 Our Dandy's Boy** opened in unison with the rest of the field and the assistant starter released the horse properly. The horse was given the opportunity of a fair start and therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 10-6-8-4-5-7-3-9-(11-lost rider).
