**Race 1:** The claim was voided for **#2 VICTORY ICE**. As a result of scratching down to a four (4) horse field, show wagering was cancelled.

**Race 2:** **#1 TEAM ASTROLOGY** was vanned off after the race.

**Race 3: JOCKEY OBJECTION/STRETCH/NO CHANGE:** Following the running of the race, Daniel Aguilar, the rider of sixth place finisher **#2 Cadillac Chrome**, lodged an objection against fourth place finisher **#5 Pete's Slew**, ridden by McKenzie King, alleging interference down the lane. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#5 Pete's Slew** did drift in slightly down the lane but there was always running room and it did not cost **#2 Cadillac Chrome** the opportunity of a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 4-8-6-5-1-2.

**TURF PARADISE RULING #18-19TP138**

Having been properly notified of a formal hearing, and having waived that right on April 27, 2019 Owner/Trainer Jose Luna Silva (ADG #17380), is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% Race Horse Adoption Fund surcharge for a total of FIVE HUNDRED TWENTY FIVE (\$525.00) following receipt of a report from Industrial Laboratories indicating blood sample #E306582 taken from the horse "D J'S SUPER TIGER" winner of the fourth race on April 1, 2019, was confirmed positive for the presence of the Class IV foreign substance DEXAMETHASONE (110 +/- 3 pg/mL).

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 7, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 8, 2019 through and inclusive of November 4, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

A.A.C. R19-2-102(19), R19-2-102(39), R19-2-106(C), R19-2-111(A)(B)(C), R19-2-112(12), R19-2-120(C)(D)(O), R19-2-121(E)

**TURF PARADISE RULING #18-19TP139**

Having been properly noticed for to a formal hearing and having waived that right on April 29, 2019, Trainer David Kern (ADG #16400) is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to have the horse "BRICKHOUSE" properly shod in the eighth race on April 27, 2019, resulting in a late scratch at Turf Paradise Race Course.

The fine set forth above must be satisfied within ten days from the date of this order. Failure to comply with all requirements of this ruling by May 9, 2019, will result in a one hundred eighty days (180) day suspension from (May 10, 2019 through and including November 6, 2019) and will be referred to the Director of the Arizona Department of Gaming - Racing Division with the recommendation that his license remain suspended until such time that the financial obligation is satisfied.

**TURF PARADISE RULING #18-19TP140**

Having been properly noticed for a formal hearing and having appeared, Jockey Luis Antonio Valenzuela (ADG #22497) is hereby suspended three (3) racing days (May 18, 19, and 25, 2019) for failure to make sufficient effort to maintain a straight course in the stretch, thereby resulting in the disqualification of his mount, "AWESOME E K", from second place to third place in the seventh race on April 29, 2019.

This suspension does not preclude Jockey Luis Antonio Valenzuela from riding in designated races.

The above described matter constitutes a violation in accordance with:

Having been properly noticed for a formal hearing and having waived that right on May 4, 2019, Owner/Trainer Molly Pearson (ADG #10824) is hereby fined TWO HUNDRED (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND TEN (\$210.00) for failing to honor the engagement with the horse "BOURBON AND WATER", resulting in a late scratch in the 2nd race on May 4, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 15, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 16, 2019 through and inclusive of November 12, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

**TURF PARADISE RULING #18-19TP142**

Having been properly noticed for a formal hearing and having waived that right on May 5, 2019, Jockey Fernando Manuel Gamez (ADG #11001) is hereby fined two hundred dollars (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of two hundred ten dollars (\$210.00) for misuse of the whip while aboard #7 "SASSY ROSE" in the seventh race on May 4, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 16, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 17, 2019, through and inclusive of November 13, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
