Race 2: STEWARDS INQUIRY/JOCKEY OBJECTION/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident down the backstretch involving contact between fourth place finisher **#2 Bluegrass Soul**, ridden by Kassie Guglielmino, third place finisher **#5 Trinni**, ridden by Israel Hernandez, seventh place finisher **#6 One Afleet Star**, ridden by Chad Lindsay, and fifth place finisher **#7 Champion Risk**, ridden by Paul Francis. There was also a jockey objection received from Chad Lindsay, the rider of **#6 One Afleet Star**, alleging interference against **#2 Bluegrass Soul** and **#7 Champion Risk** down the backstretch.

After reviewing the videos and taking testimony from the riders involved, the stewards determined that near the 5/8th pole **#2 Bluegrass Soul** shied away from **#1 The Grey One** who was drifting outwards, which caused a chain reaction of contact between **#2 Bluegrass Soul**, **#5 Trinni**, **#6 One Afleet Star**, and **#7 Champion Risk**. **#2 Bluegrass Soul** was disqualified from fourth place to seventh place for costing **#6 One Afleet Star** the opportunity of a better placing. **#5 Trinni** was also compromised but finished ahead of **#2 Bluegrass Soul**. The original order of finish of 1-3-5-2-7-4-6 was changed to 1-2-3-7-4-6-2.
